General

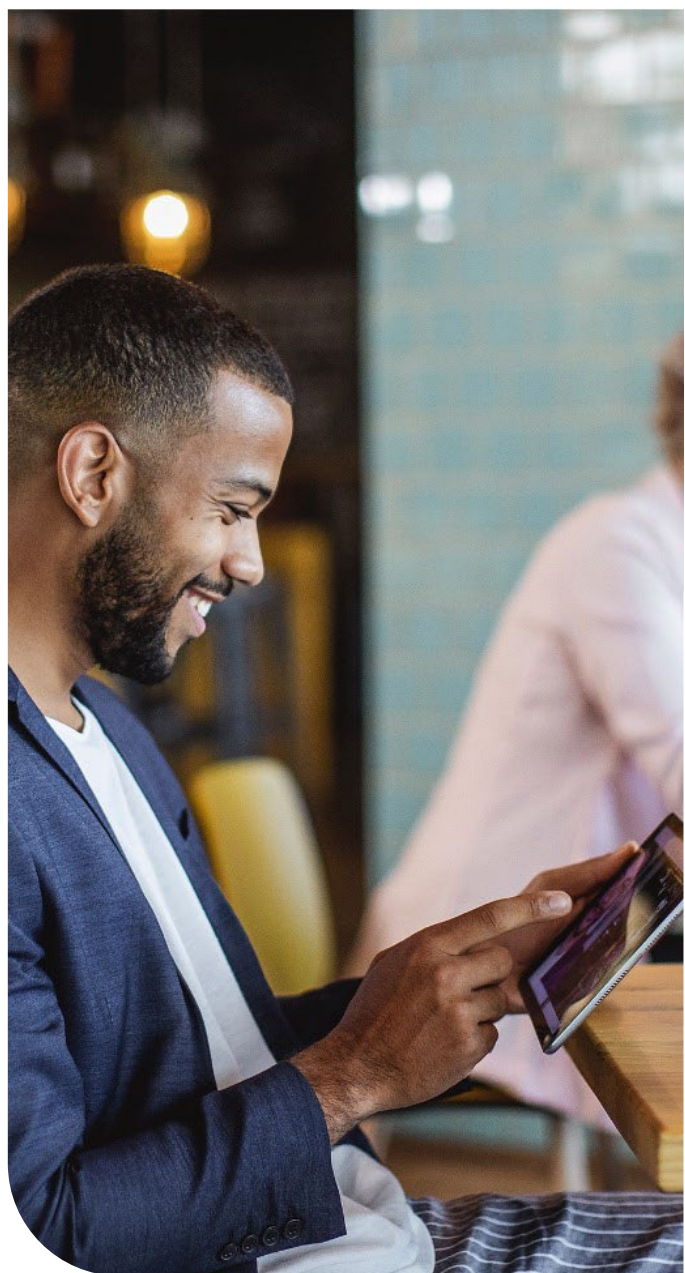
